## QUINCY SUN TAN STALLION BREEDING CONTRACT

This contract is entered into and is between the undersigned Jane Belis, known as stallion owner, and \_\_\_\_\_, hereafter designated mare owner(s).

This contract sets forth the rights and responsibilities of the parties for the 2007 breeding season. The named stallion, QUINCY SUN TAN, AQHA# 2421668/ ABRA# T-6555/ IBHA# T-10722/ APHA# Q2421668, is standing the breeding season at owner's farm at 7119 83rd ST NW, Colt Valley Farm for live cover services, and is collected for transported semen/AI by Rocky Bay Equine, Dr. Bo Weeks, DVM.

Mare owner agrees to breed the following named mare \_\_\_\_\_, BREED \_\_\_\_\_ REG # \_\_\_\_\_ to the stallion Quincy Sun Tan, for a fee of \$900.00 live foal guarantee which is subject to the following conditions:

1. A non-refundable booking fee of \$150.00 which is payable upon execution of this agreement. The balance of the breeding fee of \$750.00 together with all unpaid board and veterinary expenses shall be paid before the mare is retrieved from farm or Rocky Bay Equine clinic.
2. Stallion owner agrees to provide quality care/board to the mare/foal during the breeding visit. Mare owner agrees to pay day board at \_\_\_\_\_ per day dry mare, or \_\_\_\_\_ mare&foal. Receipts will be written for EACH statement for the MARE OWNER by Jane Belis (breeding fees/board bills/booking fees).
3. Mare owner shall deliver the mare in a healthy and sound breeding condition, free from infection or disease. MARE OWNER agrees that STALLION OWNER has permission to have the mare treated by a licensed veterinarian for any condition which might insure the mare's well being as the STALLION OWNER deems necessary or proper at the expense of the MARE OWNER.
4. The mare will not be released to the owner or owner's agent until all fees are paid to date in full. The stallion owner shall have a possessory lien on the mare for all unpaid bills. In all cases where Transported Cooled Semen is required, the entire breeding fee must be paid in advance of shipping semen.

5. An account with Rocky Bay Equine Services can be set up with credit card information and mare's information for the AI services by calling 1-360-876-1544 or 253-858-4529. The process is confidential as with any professional veterinary service and credit cards are usually the easiest method. If you wish to set up another form of account with Rocky Bay Equine, that is between the mare owner and Veterinary Clinician. Jane Belis is a separate entity from any of the shipping/collection charges/courier services that are deemed necessary to get your mare in foal through transportation of semen. 6. A PHOTOSTATIC COPY of BOTH SIDES of the mare's registration papers shall be sent in with this contract to help with identification, and for stallion breeding reports submitted to each breed association by November 30th of the breeding year.

7. STALLION OWNER will diligently try to settle the mare with live cover. However if the mare is unmanageable with live cover attempt such as kicking or threatening with the live cover breeding attempt, then the ONLY option will be ARTIFICIAL INSEMINATION through the Veterinary clinician, Dr. Bo Weeks, D.V.M.

8. STALLION OWNER guarantees a live foal from the breeding contracted for herein. "Live Foal" is defined as a foal that stands and nurses. Should the mare prove not to be in foal, aborts her foal or if the foal is stillborn, MARE OWNER shall notify the STALLION OWNER in writing within TEN DAYS of the foaling date, or the date the mare is proved not to be in foal or loses her foal. A written statement from a licensed veterinarian verifying that the mare has slipped or produced a non-viable foal must be sent to the STALLION OWNER. A substitute mare may be utilized by MARE OWNER if notification is within the TEN DAY time frame.

9. STALLION OWNER shall give the MARE OWNER a free season to the stallion the following year only.

10. In the event that more than one live foal results in the same year from the same mare, the MARE OWNER will pay an additional breeding fee for each live foal. It is understood that only one foal can be registered with their respective breed association.

11. A breeder's certificate will be issued to MARE OWNER after all outstanding expenses have been paid and upon notification of the birth of the foal to the STALLION OWNER.

12. All parties agree that the STALLION OWNER or their agents or assigns are not liable for death, sickness or accident including consequential damages caused to mare or foal.

13. It is further agreed that should the stallion expire, be sold, or become unfit prior to settling the mare, that the booking fee would be refunded, thereby canceling the entire contract. If the mare expires before the breeding occurs through this contract, another mare may be substituted for the current year or the following year.

14. This contract is Non-Assignable and Non-Transferable. The mare owner is responsible for all personal property taxes and insurance on the mare/mare/foal at the option of each owner. This contract is entered into the State of Washington and will be interpreted and enforced under the laws of Washington State. If any clause in this contract is against State Law, then that clause will be null and void.

15. This contract represents the entire agreement between the parties named. No other agreements or promises, verbal or implied are included unless specifically in this WRITTEN contract. Additional conditions should be individually initialed by each part. If none, initial here\_\_\_\_\_.
